The Master Agreement is a contract form between Owner & Contractor that is applicable for a defined period of time and is intended to establish contractual terms/conditions (excluding scope, time & cost) for multiple projects during that time period. <b>CCDC 5B – 2010 Construction Management Contract for Services &amp; Construction (*Includes 2 seals)</b> A standard contract between Owner & Construction Manager to provide advisory services during the pre-construction phase and perform the required Work during the construction phase. At the outset, the Work is performed on an actual-cost basis, plus a percentage or fixed fee which is applied to actual costs.
